



Over 15,000 drawings, photos, articles and essays have been interlinked in a specially created digital program for reference. The Archives are available at a nominal subscription to colleges, offices and individuals around the world.

The requirements and conditions for use are as under:

### A. PROTOCOL

- Only one computer can log into the program at a time. Multiple logins are not possible on a single subscription.
- The website is available continuously, 24 x 7. However, it may undergo maintenance annually during which it will be temporarily unavailable. For scheduled maintenance, the subscribers will be notified in advance.
- Username and password once generated after the application process, should be shared with CCF at [admin@charlescorreafoundation.org](mailto:admin@charlescorreafoundation.org)

### B. COMPUTER REQUIREMENTS

- Google Chrome as the Internet browser. Ad-block must be disabled.
- Minimum Screen resolution for the monitor is 1280 x 800 pixels.
- Minimum 2 mbps broadband Internet connection.

### C. SUBSCRIPTION FEE

#### i. Bank transfer through Indian banks:

One-time Registration Fee*:	₹ 10,000
3-Year Subscription Fee:	₹ 7,500
GST at 18%:	₹ 3,150

#### ii. Wire transfer through foreign banks:

One-time Registration Fee*:	₹ 15,000 (USD 195)
3-Year Subscription Fee:	₹ 10,000 (USD 135)
<b>Total fees =</b>	<b>₹ 25,000 (USD 330)</b>

*Includes applicable taxes and bank charges*

Please note that after 3 years, you are only required to pay subscription fees\* which is currently ₹ 7,500 (for Indian banks) and ₹ 10,000 / USD \$135 (for foreign banks).

Subscription fee is subject to change.
